NZL Report

Big impact on NZ level lacrosse was/is COVID which therefore gives us massive travel restrictions. No U15, U18 or men's team played overseas this year.

U15 – Held in Cambridge. Waikato won this. They put in two teams against Auckland's one team. Good to see numbers growing at this young age. Looking forward we are keen to keep this age group developing. It is key to get players as young as we can.

U18 – 3 game series between Waikato and Auckland held in Waikato. Very competitive teams with Auckland winning 2 of the 3 games and picking up the win. Game scores where within 1-2 goals and games when into overtime.

We will continue to have the NZ nationals and aim to send teams to Australia. The aim is to be able to send regional teams to Australia, but we need to weigh up whether it is worth it at the time and each year this will have to be assessed. We also need to look at a calendar of events for the year and ensure all events talk to each other.

We are aiming to send an U20 team to Australia in January in leu of U18 over the past 2 years.

Senior nationals were held in Wellington this year. With 4 teams competing. Auckland, Waikato, Wellington and a president's team. In the past Auckland has sent two teams to nationals, although they made the decision focus on one team. We made the decision to have a president's team. Having a president's team allowed for players from Canterbury to come up and play. Originally, we have 6 players keen although on 2 managed the journey up to Wellington. The rest of the team was for players of the other regions who didn't make their first team. This was offered to all regions although team was mainly filled up with Auckland players. Auckland placed first, Waikato second, Wellington Third and Presidents fourth.

World Cup – Men's team was about to start early training programs for the next world cup, although as it has been postponed due to COVID, so too has the training. Hopefully with vaccines and travel restrictions easing we will be able to participate in the next world cup. Logistics get a bit difficult as we need to host a qualifying tournament.

Highschools – Auckland/Waikato. Auckland has 6 schools competing against each other (with 2 junior teams). Waikato has XX schools competing against each other. I understand there are schools from both Cambridge and Hamilton playing.

Club leagues – Auckland and Waikato club league

Wellington/canterbury – still developing with the aim to get into highschools.

Waikato 52 mens players

Auckland 121 mens players (down 30 players from last year)

Qualification Tournament – decision made in September to play in April. Likely postponed again.
